(“Intertrust”), a leading global provider of expert administrative services to corporate, fund, capital markets and private wealth clients, in connection with its acquisition of Viteos, a provider of leading-edge technology solutions for U.S. funds, from PPC Enterprises LLC, FiveW Capital LLC (an affiliate of 22C Capital) and Viteos management, for an enterprise value of \$330 million. Viteos has its headquarters and sales team in the U.S. and is supported by Centers of Excellence in India.
