Simpson Thacher represented affiliates of Digital Colony Partners in connection with its acquisition of Landmark Dividend LLC (“Landmark”). The transaction closed on June 2, 2021. Financial terms of the transaction were not disclosed.

Landmark is a real estate and infrastructure acquisition and development company focusing on the digital infrastructure, wireless communications, outdoor advertising and renewable power generation industries. Landmark currently manages over 5,000 assets originated on behalf of Landmark, its active private investment vehicles and Landmark Infrastructure Partners LP (NASDAQ: LMRK). LMRK is a publicly-traded subsidiary of Landmark established to acquire, own and manage a diversified, growing portfolio of real property interests and infrastructure assets.
