

KKR to Invest in Groundworks

Simpson Thacher is representing funds managed by KKR in connection with their agreement to significantly invest in Groundworks, LLC (“Groundworks”). The transaction, which is subject to receipt of required regulatory approvals and satisfying other customary closing conditions, is expected to close by the end of the first quarter of 2023.

Founded in 2016, Groundworks has more than 4,000 employees operating in 33 states providing residential foundation and water management solutions, including foundation repair, basement waterproofing, crawl space repair and encapsulation, plumbing, gutter installation and concrete lifting services. Groundworks’ brands have served over one million customers in the United States.
