

## Revelstoke Capital Partners Raises Funds with \$1.7 Billion of Committed Capital

Simpson Thacher represented Revelstoke Capital Partners in connection with the formation and raising of Revelstoke Capital Partners Fund III, L.P. (“RCP Fund III”) and various affiliated investment vehicles totaling \$1.7 billion. RCP Fund III substantially surpassed its target of \$1 billion.

Revelstoke is a Denver-based private equity firm with \$5.8 billion of assets under management. Including RCP Fund III, Revelstoke has raised three flagship private equity funds, three single-asset continuation vehicles under the EPIC series, and numerous co-investment vehicles since its inception in 2013. The firm has raised \$3.7 billion of equity commitments since 2018 to execute on its strategy of working with entrepreneurs and management teams to build market-leading healthcare services companies.
